Ethical boundaries in patent law

Munich, 13. 4. 2010

Dear Sir or Madam.

Testbiotech made it publicly known in November 2009 that the patent EP1794287 had been granted to Merck Serono, and it has now filed an opposition at the European Patent Office in Munich. Further research by Testbiotech found that Merck Serano had several other similar patents. These patents were partially granted in Europe and also registered in other parts of the world. See overview in the table attached

The content of these patents, especially the wording of the claims, is not acceptable from an ethical point of view. Such patents are likely to foster commercialisation of the human body. Further, we found a strong tendency within the patent applications as filed via Applied Research Systems ARS Holding to use claims that also cover methods of medical treatment. This endangers a doctor's freedom to choose the most appropriate therapy for each patent. Therefore, European patent law does not allow these kinds of patents.

Testbiotech is committed to clarifying the boundaries in patent laws. Our group of experts hopes that this recent case will help to avoid further commercialisation of the human body. We see this case as an opportunity for Merck Serono to clarify its patent strategy and to abandon those patents which violate basic ethical boundaries. We would be more than happy to
